

## Construction of access roads inside TSF3 & TSF4

Expressions of Interest Requested  
Kinross Tasiast Mauritanie Ltd. S.A. (TML S.A.)

Tasiast Gold Mine commenced operations in 2007 and in 2010 TMLSA, a wholly owned Kinross Gold Corporation subsidiary, acquired the mining lease. The open pit operation is located in the Saharan desert of western Mauritania approximately 300km north of the capital, Nouakchott and 162km east-southeast of the port city of Nouadhibou in Mauritania, West Africa.

TMLSA is seeking interest from contractors qualified in performing earthworks for the construction of the Tasiast Mauritanie Limited S.A. (TMLSA) access roads and platforms for Tailings Storage Facility 3 (TSF3) and for Tailings Storage Facility 4 (TSF4) located at the Company Tasiast mine site.

The Services shall be performed in accordance with the applicable standards and specifications of the earthworks required.

### Technical & Safety Requirements

1. Performing placement of Access Road Fill to construct access roads over the tailings surface.
2. Placement of Platform Fill to construct platforms for a field investigation program
3. Removal of safety berms by blading the materials down the slope upon completion of the field investigation.
4. Perform the construction of access roads with respect to the specifications and within agreed period
5. Only bidders providing evidence of a past successful experience in similar projects, will be invited to participate in the bid.

### Commercial Requirements

1. Interested contractors should **be registered having the RC and N.I.F numbers;**
2. Indicate experience in the requested domain(s) **at least minimum three years in** Access Roads Fill, Platform Fill and Safety Berm removal;
3. Tax clearance certificate or exemption and **proof of compliance to social security requirements.** The Company will establish if this is a requirement in the country;
4. **Referees**, at least list three most important clients, including the contact name, title, Email address, the length of contract and contract value;
5. **CVs of the relevant key personnel**, such as equipment operators, survey technician, equipment maintenance lead and Managing Director or the Site Manager who will be supervising the works, with the adequate experience in their areas of expertise in earthworks services.
