Tasiast Gold Mine commenced operations in 2007 and in 2010 TMLSA, a wholly owned Kinross Gold Corporation subsidiary, acquired the mining lease. The open pit operation is located in the Sahara desert of western Mauritania approximately 300km north of the capital, Nouakchott and 162km east-southeast of the port city of Nouadhibou in Mauritania, West Africa.

TMLSA is seeking the interest of interested business partners who can conduct the **renovation of existing LV workshop**. It seeks to engage a qualified contractor to design and build the new offices and rehabilitate the mechanical workshop hangar to the highest international standards. The contractor will be responsible for all aspects of the project, including engineering and design, procurement of materials, construction, project management, supervision, etc.

Technical Requirements

The services includes but not limited to the following:

1. Furnish a comprehensive team of experienced and qualified engineers, designers, supervisors, skilled and unskilled laborers, along with all necessary materials, methods, equipment, tools, and accessories. This team will be responsible for designing, supplying, fabricating, pre-assembling, field erecting, and commissioning the new shop as detailed in this document, ensuring a thorough and accurate installation.
2. Supply seasoned and capable project control personnel who will be tasked with creating and maintaining the project schedule. They will also provide timely progress reports on the work, meeting the requirements set forth by the Owner.
3. Provide proficient and certified personnel including purchasers, QA/QC inspectors, shippers, contract administrators, and any other necessary staff for the procurement and transportation of all items to be supplied by the contractor. This includes overseeing equipment procurement, as well as planning, purchasing, shipping, and inspection services.
4. Demonstrated experience in designing and building industrial facilities to international standards.
5. Previous experience with similar rehabilitation projects, preferably in remote or challenging environments.

Commercial Requirements

1. Interested contractors should **be registered having the RC and N.I.F numbers**; Indicate experience in the requested domain(s) **at least minimum three years in Provision of Similar Services**.
2. Tax clearance certificate or exemption and **proof of compliance to social security requirements**.
